NOTICE TO BIDDERS A NOTICE IS HEREBY GIVEN that sealed Bid Packets will be received by the Borough of Union Beach, County of Monmouth, State of New Jersey on Thursday, April 22, 2021 at 10:00 AM prevailing time at Union Beach Borough Hall, 650 Poole Avenue, Union Beach, NJ 07735, at which time and place the Bid Packets will be publicly unsealed and its contents announced in public for the 2021 CAPITAL IMPROVEMENT PROGRAM. Bid Packets shall be placed in the Borough Hall westerly vestibule off Poole Avenue in a designated area during normal business hours. The bid opening will be conducted in the Borough Hall court room and can be witness remotely. The Borough Clerk shall provide the conference room platform upon request. Copies of the submitted bids will be available for review upon request and will be provided electronically. The scope of Work contemplated for the abovenamed Project includes the installation and/or repair of existing drainage pipes and inlets, installation of ADA accessible curb ramps, installation of concrete curb and sidewalk, roadway milling, full depth pavement reconstruction and surface course installation, as well as all other Work of any type or description necessary for contemplation of the Project, whether or not specifically described in these Contract Documents. All Work on this Contract shall be completed within ninety (90) Calendar Days from Notice to Proceed. Contract Documents and Plans for the proposed work, which have been prepared by Edward G. Broberg, P.E., of the firm of T&M Associates, will be made available electronically or at the office of said Engineer at 11 Tindall Road, Middletown, NJ, 07748. Interested bidders must send an email request to Patti Sirico at PSirico@tandmassociates.com. Bidders interested in receiving bid packages electronically will be provided with a link to download the documents after receipt of proper notice and payment of a non-refundable charge of Twenty-Five Dollars (\$25.00) payable to "T&M Associates" to defray the cost thereof. Bidders interested in obtaining hard copies of the documents in person from the office must make an appointment with Patti Sirico. Bidders will be furnished with a hard copy of the Contract Documents upon proper notice and payment of a non-refundable charge of One Hundred Dollars (\$100.00) payable to "T&M Associates" at the offices of T&M Associates to defray the cost thereof. The provided Bid Packet must be completed in the manner designated in the Contract Documents, must be enclosed in a sealed envelope bearing the name and address of the Bidder and the name of the Project on the outside and must be addressed to the Borough of Union Beach. Also, Bid Packets must be accompanied by a Statement of Consent of Surety from a surety company holding a Certificate of Authorization to do business in the State of New Jersey and either a Bid Bond or a Certified Check drawn to the order of "The Borough Union Beach" for not less than ten percent (10%) of the total bid price amount, except that the check shall not exceed \$20,000.00. The successful Bidder is hereby notified that a Performance and Payment Bonds for the full amount of this Project is required. The award of the Contract for this Project will not be made until the necessary funds have been provided by the Borough of Union Beach in a lawful manner. Please be advised that this Project is being funded through the borough of Union Beach. By virtue of Executive Order #34 (1976), vendors currently suspended, debarred or disqualified are excluded from participating on

this Project. The successful Bidder shall be required to comply with the applicable statutory requirements of the Contract Documents and Plans which include all of the following: (i) N.J.A.C. 17:27; (ii) N.J.S.A. 10:5-31 et seq.; (iii) Business Registrations (N.J.S.A. 52:32-44); (iv) Prevailing Wage Act (N.J.S.A. 34:11-56.25, et seq.); (v) Public Work Contractor Registration (N.J.S.A. 34:11-56.48); and (vi) Affirmative Action Requirements (N.J.S.A. 10:5-1, et seq.); and any other legal requirements applicable to this Project. The Borough of Union Beach intends to award this Project to the lowest responsible and responsive Bidder in accordance with applicable law. The Borough of Union Beach reserves the right to reject any and all Bid Packets to the extent permitted by law. An award will be made, or Bid Packets will be rejected within sixty (60) Calendar Days after the opening of the Bid Packets, during which time the Bid Packets shall be irrevocable and unavailable to withdraw by Bidders, unless otherwise extended in the Contract Documents.
